Your personal data is processed to facilitate your participation in the Gala (whether as participant, nominee or member of the jury).

The personal data you provide, including your name, surname, bio and contact details, is processed on the basis of your consent (Article 6 sec. 1 letter a) of the Regulation (EU) 2016/679 of The European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation "GDPR")). This consent may be revoked at any time.

If you have voluntarily provided data referred to in Art. 9 sec. 1 GDPR, such as special categories of personal data such as (e.g., revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, data concerning health or sexual orientation) it is processed on the basis of your consent (Art. 9 sec. 2 letter a of the GDPR) which can also be revoked at any time.

The data controller will not transfer personal data to any international organisation.

As a general rule, the data controller does not transfer the data to another third party country.
